Dear Designhill,

I request you to remove an item, listing or contest from the Designhill website as the content violates the right of a third party.

I make the following statement **UNDER OATH and acknowledge that any bogus oath subjects me to PENALTY FOR PERJURY:**

1. I own certain intellectual property rights of which details are given in Item1 of the Schedule["IP Rights"], or I am an authorized agent of the owner ["IP Owner"]
2. I believe that the item, listing or contest mentioned below in item 2 of the Schedule ["Infringing Item"] have infringed the Intellectual Property rights. I have enough grounds to believe that the IP Owner has not assigned or licensed IP Rights to the alleged infringer or there was no consent and authorization for use of the IP rights.
